- Private/Public Water supplies
- Private Waste Water Treatment
- Vector Control
- **■** Food Safety
- Other common environmental health problems

- Involved with initial planning process, and integration as part of initial EH response in affected parishes
- Iowa first state to send EH Professionals through EMAC to LA.






FOOD SAFETY

- Aprox.15,000 LA permitted retail establishments to be assessed or inspected
- Commercial seafood inspections completed to assess and insure food seizure and witness proper food destruction
- Dairy operations assessed for hurricane damage
- IA-EHRT members assessed and inspected aprox. 500-1000 sites within St. Tammany and Washington Parishes.
- IA-EHRT members assessed and inspected over 300 sites in New Orleans within two day period prior to departure, out of 7000 permitted sites in area.
- 1000's of tons of destroyed food witnessed or observed





Damage Extremely Variable

- Many establishments gone
- Others only lost power
- Some had water supply problems
- Quite a few no damage
- Lot's of flooding
- Others wind damage
- Worker shortages

Damage Assessment Surveys

- Loss of power?
- How long was power out?
- Freezer/ Refrigerator inventory and function?
- Flooding?
- Physical damage to structure?
- Was food discarded and how?
- Any food left to be thrown away?
- Needs reinspection or approved for reopening ?
















Hazards Encountered

- Broken Glass/ Debris
- Mold and More Mold
- Perished Food
- Power Lines Down
- Lots of People in a Hurry
- Loss of Traffic Control Lights/Signs

Public Water Supply Coordinated effort with EPA Region 6/LDHH/LRWA/IA-EHRT/Illinois Response Team Assessments completed on over 500 PWS in effected areas















































Lessons Learned

Sometimes your responders are VICTIMS of the disaster


- Plan for the worst case and respond to the emergency as needed
- If you have exercised or trained for a specific emergency or disaster it will probably occur
- Train and exercise with all your response partners

Continued.....

- Plan to be self sufficient for 2 weeks NOT 72 HOURS
- Plans are not worth the paper they are written on if you cannot execute them
- FOLLOW ICS!!!!!!!!!
- Treat people as people not animals
- Account for the animals in your plan
